Over the course of the school year our **School Improvement Council** reviewed the following topics:

- Mrs. Erin Greenway presented the schools COVID-19 procedures and discussed the virtual format for this year's meetings. She discussed the lunch schedule for our students which went from one lunch/tutoring session for the entire student body to a four lunch schedule to accommodate social distancing. She also discussed the scheduling options offered to accommodate the needs of our students which include hybrid and virtual learning models. Finally, she spoke about releasing the student to their classes earlier in order to eliminate crowding during the breakfast hours.
- Our SRO Officer Shandrel Holcombe addressed the committee about the Alive at 25 safe driving program. He put an emphasis on being proactive with the road awareness of our students. Educating students about safe driving practices is of the utmost importance. The committee received the information favorably and would like for us to move forward in implementing the program.
- The committee reviewed the District Five Facilities and Demographic Study to look at the growth in our district and the impact that it will have. We focused on the projections for our school and discussed the district's plan to address this growth. During the 2015-2016 school year our enrollment was 2339 students and it was 2564 students during 2019-2020. This was an increase of 225 students in four years. We have been given a projected enrollment number of 2945 students for the 2024-2025 school year. Our district has initiated phase two of our building plan. Phase two will eliminate a large portion of the older parts of the building and replaces that with more than thirty classrooms. This construction is necessary to help us alleviate the impact of the increased student enrollment.
