#### 2015-2016 SCHOOL YEAR ACCOMPLISHMENTS

East Elementary School serves pre-kindergarten through third grade and is home to approximately 520 students who present a variety of abilities, economic and cultural backgrounds, basic needs, and learning styles.

- Formed a community partnership with Zaxby's to recognize the students with the highest scores or the most growth between MAP testing sessions.
