# South Elementary School Act 135 Summary Report February 14, 2017

The principal, Dr. Louise E. Goings, and School Improvement Council members have prepared this Annual Summary Report for parents and community members interested in the school. The report reviews accomplishments made last year, as well as, test score data and accreditation information.

ACT 135 mandates that schools develop a comprehensive plan to improve the academic performance of students and educational services for students. South Elementary developed a five year School Renewal Plan with accountability elements for 2012-2017. It was submitted to the State Department of Education. The school is currently completing goals and objectives for the fifth year of the plan and has begun preparing the elements for the 2017-2022. The School Renewal Plan includes performance goals in four areas: Student Achievement, School Climate, Teacher /Administrator Quality and Certification/Professional Development.

## MISSION STATEMENT

At South Elementary School, we believe it is our responsibility to offer authentic learning environments that will develop our students' abilities to critically approach their world and learn to connect, collaborate, create, and communicate their ideas, by instilling 21st century skills and inspiring lifelong learning in every student.
