ACT 135 mandates that schools develop a comprehensive plan to improve the academic performance of students and educational services for students. Stewart Heights developed a five year School Renewal Plan with accountability elements for 2012-2017. It was submitted to the State Department of Education. The school is currently completing goals and objectives for the third year of the five year plan. The School Renewal Plan includes performance goals in four areas: Student Achievement, School Climate, Teacher/Administrator Quality and Certification/Professional Development.

ESEA/Federal Accountability Rating System

In July 2013, the South Carolina Department of Education was granted a waiver from several accountability requirements of the federal Elementary and Secondary Education Act (ESEA). This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target. This analysis results in a letter grade for the school rather than the pass/fail system of previous years. Stewart Heights Elementary earned 72.6 points which converts to a grade of “C” for the 2014 school year.

1. Provided reading instruction using guided, shared and independent reading strategies.

10. Provided staff development opportunities for teachers in relation to the South Carolina Palmetto Assessment of State Standards (SC PASS) test, technology, Peer Assisted Learning Strategies (PALS) in ELA, and Common Core State Standards (CCSS) and writing across the curriculum.
11. Assessed all certified staff members with the state's technology proficiency assessment to determine their proficiency level.
12. Increased technology integration through the use of portable iPad labs and mini notebook computer labs.
13. Recognized students with good behavior at quarterly breakfasts.
14. Provided weekly guidance lessons for students in kindergarten through third grade.
15. Published weekly newsletters to inform parents of standards being taught and school programs.
