PROGRESS ON SIC GOAL FOR 2020-2021

Our School Improvement Council has continued to meet monthly on Zoom throughout the 2020-2021 school year. We are very grateful for the technological advances our district has made this past year since the beginning of the COVID-19 pandemic. With the restrictions on visitors allowed in the school building this year due to COVID-19, the council decided to focus on enhancing the school environment, including outdoor areas of our school. A grant was obtained from our PTA to purchase outdoor picnic tables for one of our courtyards. This area was used commonly for team building with our staff during lunch on virtual days. It is also a great space for a class working on a special project or any class engaging in learning activities outside.
