
Saxe Gotha Elementary School Annual Report to Parents

Progress on Goals for 2014-2015

- We continue to be a Leader in Me Lighthouse School and continue our school-wide implementation of Stephen Covey's 7 Habits for Highly Effective People. It emphasizes 21st century leadership skills for all students.
- Our PBIS (Positive Behavior Interventions and Support) and Leader in Me teams worked together to combine our PBIS system and Leader in Me initiative into LEAD (Live Respectfully, Engage Responsibly, Act Safely and Dream Big).
- The entire school gathers monthly for a LEAD rally where students, staff, and community members are recognized for practicing the 7 Habits and outstanding leadership efforts. The integration of the PBIS-Positive Behavior Intervention Support program and Leader in Me took place this year. LEAD (Live Respectfully, Engage Responsibly, Act Safely and Dream Big).
- A spring Leadership Day is held for community members and visitors from other schools to observe and experience the implementation of Leader in Me at SGE.
- Student-led conferences are conducted twice a year. Students explain their goals, personal and academic, to their parents. They then guide their parents through their progress.
- The Response to Intervention program continues to assist students who fail to meet grade-level criteria for academic success. This was the third year of implementing the Extended Day RTI program. In this program, students in grade 3-5 are served after school rather than during the school day allowing them to receive full core instruction in the classroom during the day and extra assistance after school.
- All students hold a leadership role with in their classroom or within the school. Students displaying exceptional character and leadership qualities are given responsibilities such as Student Council, Safety Patrol, and Lighthouse Team.
- Technology, such as iPads, iPods and personal GPS devices are used to broaden the scope of learning for our students and enhance technology skills they will need as 21st century employees.
- Computer labs are open to students before school begins each morning to allow additional time for reinforcement and enrichment of math and reading skills.
- Special Education Teachers Lucie Bingham, Kelli Liles, and Brian French received a Project Unify grant for Special Olympics.
- Our math and literacy coaches facilitate training for teachers on math and literacy curriculum (respectively), offer classroom assistance, and conduct reinforcement and enrichment activities for students.
- First have access to First in math, Imagine, learning, and Achieve 3000 to help improve math and ELA skills on the computer and iPad.
