#### PROGRESS ON SIC GOAL FOR 2022-2023

Our School Improvement Council has continued to meet regularly on Zoom during the 2022-2023 school year. The council has focused efforts on increasing and promoting engagement with business and community partners. New and existing initiatives have enriched our academic content, addressed student needs, and created connections between students and their community. The relationships between our school and community stakeholders is an integral part of empowering each child to design the future.

Collaborative Planning Day Clubs were implemented this year to engage students in third, fourth and fifth grade to develop power skills with other students while learning about a topic of interest to them. Community and business partners assisted with donating specific items for clubs, speaking to students, and providing hands-on demonstrations for students. It was exciting to see the relationships teachers and students strengthened while engaging in learning on topics of interest.

Mentor Programs provided opportunities to increase community involvement throughout the school. SGE partnered with White Knoll High School and LOAD (Lexington One Athletic Development) to implement High Five Fridays. Coaches and students with the White Knoll High School basketball, baseball, and softball programs greeted our students upon arrival in the bus loop, car line, and lobby. They visited each grade level and participated in Morning Meetings with the class and read with our students.

Our partnership with the University of South Carolina continued this year. Students from USC's School of Education worked directly with students in third and fourth grade with our "Tall Teachers, Small Teachers" program to provide learning experiences during Reading and Writing Workshops. USC students worked individually with students to observe students' reading and writing habits, reflect on these observations, and plan specific instruction. These personalized lessons helped our students grow tremendously in reading and writing. This program concluded with both Tall Teachers and Small Teachers forming book clubs in which together they read and discussed some of today's most popular children's' chapter books.

This year students from the University of South Carolina's College of Pharmacy Kappa Psi Fraternity continued their weekly reading to classes of second grade students at SGE. In addition, during the fall semester the College of Pharmacy students sponsored a socks and underwear drive for our clothes closet here at SGE.

A partnership was formed with the Lexington County Sheriff's Department with a new First Responders Readers program at SGE in which deputies volunteered time to read with selected students. SGE also invited retired educators to be involved with a new Retiree Readers program. Mentors in such programs read weekly with first grade students to build self-confidence and self-esteem while promoting stronger relationships with parents, teachers and community members.

Lexington United Methodist, a local church in our community, was instrumental in making a Snack Pack Program possible at SGE. Each week, 199 snack packs were distributed to students in all grade levels. Our fifth grade leaders were instrumental in making the deliveries each Friday. Students having the security of knowing they will not be hungry while away from school is such a comfort. Our students leave with their snack packs knowing their community cares for them in and out of school.

SGE welcomed back Vehicle Career Day this Spring. This event was hosted by our School Counselors to bring career awareness to our students. Students had the opportunity to explore a variety of careers, ask questions, and see vehicles that are utilized in each career. This was a fun interactive event that exposed kids to possible future careers. This event required community participation to execute and we are thankful to all of our partners that made the event possible.

Our SIC is very grateful for all of our community and business partners that contributed to the success of the 2022-2023 school year.
