Whittaker is a Title I School with a poverty index of 97%. Each year, Whittaker strives to improve upon the tradition of academic achievement that has been established by providing our students with real world experiences that will positively impact their futures and secure the best academic foundation can be offered to a millennial student.

The Whittaker School Faculty plans and collaborates regularly in order to provide a challenging and stimulating curriculum, in a one-to-one digital environment on a daily basis. All students from Pre-K to 5th grade received a digital device that is used to provide personal learning experiences. We believe that an academically focused and a technologically blended environment is the key to preparing our students for a successful future. Academic achievement is our primary focus and using data to monitor, assess, and adjust instruction based on the needs of our students, is our ultimate goal.

During the 2017-2018 school year, WES' Title I Program supported 184 total students during specified Title I/Tier II instructional times. The Title I Program also supported 238 students for Tier II instruction during Leveled Literacy Intervention time. Because of the outstanding resources afforded through Title I classroom teachers and students experienced significant MAP growth in reading and math.

Whittaker's parents are a vital part of our school environment and our WES parents work diligently with the school to create a school-to-home relationship that is positive and productive. This year we have been able to provide 6 parent learning engagement nights that supported the instructional learning environment. Students and parents received information pertaining to MAPs, Read to Succeed Law, SCREADY and SCPASAS data, and school wide initiatives that support the ongoing achievement of students.





SCREADY Reading




SCREADY Math



This year we implemented ROAR Bucks to provide moments to "Catch Students ROARING" to allow students to earn tickets for prizes and other incentives to promote a positive school climate and decrease behavioral infractions. Our hope is that as we continue to implement ROAR Bucks, students will build an innate desire to want to behave and work in a positive learning environment.

WES BETA Club students and staff participated in a variety of community service projects this school year. Our BETA students were afforded the opportunity to travel overnight to Moorehouse and Spelman colleges as a part of our school's "Get Ready for College Tour. We were fortunate this year to build a partnership with Arbor Trust Investment Group, who provided gifts and tokens of gratitude to our BETA students as well as to those students receiving the HERO of the Month Award.
