Our current enrollment is approximately 250. This gives us an approximate Student/Teacher ratio of 16:1 in the core classrooms.

Due to the shifts in our community population, our enrollment fluctuates from year to year across the grade levels.

Staff positions are utilized in many ways to support our students, and assignments vary as needed to accommodate maximum student learning. All certified staff is Highly Qualified as designated by the No Child Left Behind Act, and we currently have 4 Nationally Board Certified teachers on staff, with several of our staff in advanced courses for future growth opportunities.
